These Original Petitions have been filed by GAIL India Ltd., assailing the orders of the learned District Judge, granting compensation to the respondents herein, under Sections 10(2) and 10 (3) of the Petroleum and Minerals Pipelines (Acquisition of Right of User in Land) Act, 1962 (hereinafter referred to as ‘the Act’ for short).

2. Sri.K.Anand, learned Senior Counsel, instructed by

Sri.Vishnu S., appearing for GAIL India Ltd. in some of these matters; as also Smt.Preetha and Sri.Mohammed Al Rafi, appearing for them in others, predominantly argued that the learned District Judge was in error in having granted compensation for diminution of land value because, this is a component which ought to have been decided only under Section 10(4) of the ‘Act’; and that too, after the competent Authority had evaluated its value. They also took objections against heads of compensation granted by the learned District Judge, however, confining to the quantum relating to the value of the trees, viz a viz the amounts that would have been required for its maintenance. They, however, thus conceded that if this Court is inclined to consider and accede to their prayer for deletion of compensation granted by the learned District Judge towards diminution of land value, their client would not press any other contentions, including to one above, which have been impelled in these Original Petitions.

3. Sri.K.P.Anil Kumar – learned counsel appearing for the respondents, very pertinently admitted that the Competent Authority has already fixed the land value and has passed Awards

under Section 10(4) of the ‘Act’. He, therefore, prayed that if this Court is inclined to accept the afore request of GAIL India Ltd., and to delete the compensation granted by the learned District Judge for diminution of land value, his clients may be reserved full liberty to deal with the Awards under Section 10(4) of the ‘Act’ as mentioned above, in terms of law, including to seek enhancement of compensation granted by the Competent Authority.

4. Sri.Ajith Krishnan – learned Standing Counsel for the competent Authority in all these cases, confirmed that his client has passed two orders, namely, one under Section 10(2) and the other under Section 10(4) of the ‘Act’. He added that the latter Award has been issued much later than the impugned orders of the District Judge.

5. When I consider and evaluate the afore rival submissions, it is evident that if the respondents are to be given compensation both under Sections 10(3) and 10(4) for diminution of land value, it would certainly amount to unjust enrichment.

6. In the cases at hand, it is without doubt – and as is expressly admitted – the Competent Authority has now passed an

Award under Section 10(4), after evaluating the value of land; and obviously, therefore, the respondents would get the opportunity of challenging it appropriately before the District Judge, for which, all their contentions are certainly available to them.

7. That said, however, I notice from the impugned Awards that the learned District Judge has gone ahead and fixed the market value on its own, to then determine the compensation for diminution of land value, which, in my firm view, could not have been done, except under Section 10(4) of the ‘Act’. Of course, the compensation under Section 10(3) of the ‘Act’, for temporary severance of the land, on account of laying of the pipeline could have been considered, but the learned Judge has not done so, but, in fact, has gone ahead to fix the compensation of diminution of land value – which, as I have already said above, he could not have done.

In the afore circumstances, I allow these Original Petitions and set aside the impugned orders of the learned District Judge; however, only to the extent of the component of diminution of land value, which has been granted purportedly under Section 10(3)

of the 'Act'.

I, however, make it clear that my observations herein will not fetter or trammel the rights of respondents in dealing with the Award stated to be issued by the competent Authority under Section 10(4) of the 'Act'; for which purpose, all their contentions in that regard are left untouched.
