#### JUDGMENT

All that the petitioner seeks for is an easy installment facility to wipe off the liability due to the 2<sup>nd</sup> respondent Bank under a defaulted credit facility.

- 2. Heard the learned Counsel on both sides.
- 3. On 26.07.2023, this Court had directed the petitioner to remit an amount of Rs.75,000/- (Rupees seventy five thousand only) towards the loan account within two weeks from that date. It is reported that the said direction has been complied with by the petitioner.
- 4. Learned Standing Counsel for the Bank submits that, as of now approximately Rs.11,00,000/- (Rupees eleven lakhs only) is the remaining due to the Bank.
- 5. Considering the financial constraints pointed out by the petitioner and also the fact that the petitioner has

complied with the interim direction of this Court, I am inclined to grant a reasonable installment facility to

the petitioner.

6. The petitioner shall pay off the total amount due to the Bank, with interest and costs, in 10 equal

monthly installments commencing from 30.10.2023. In case

of default in payment of any single installment, the

petitioner will lose the benefit granted under this

judgment.

The writ petition is disposed of accordingly.
