JUDGMENT

These writ petitions are connected matters and therefore, I am disposing of these writ petitions by a common order.

2. These writ petitions are filed with a grievance that Ext.P2 guidelines are not implemented.

3. When these writ petitions came up for consideration on 14.11.2022, this Court passed the following order:-

"From the arguments advanced, I am convinced that steps are being taken by the Oil marketing Companies, to implement the policy for inter and intra company transfers. Certain instances of intra company transfers have also been pointed out by the learned Standing Counsel.

2. Learned Counsel for the petitioners submit that, although submissions are made that, efforts are being taken to implement the policy, the ground reality is otherwise, and the petitioners are finding it extremely difficult to pull on with the minimum number of customers provided.

3. As pointed out by the learned Standing Counsel, the policy cannot be implemented in individual cases and even the requirements for

connection and other ancillary materials for different Oil Marketing Companies are different and there is an incompatibility issue with respect to the systems being operated by different companies also. The submissions make it clear that the implementation of the inter company transfers is progressing but may require some more time.

The oil marketing companies may take necessary steps to hasten the process.

Post after a month.”

4. Thereafter, the W.P.(C) No.29046/2021 came up for consideration on 21.02.2023, this Court passed the following order:-

“I.A.No.3/2023

This is an application filed by the writ petitioner seeking to carry out a correction in the 2nd line in the 1st paragraph of the writ petition.

Heard respective counsel and perused the affidavit. There is no objection from the respondents. I.A will stand allowed.

Registry is directed to carry out necessary amendment in the writ petition accordingly.

I.A.No.2/2023

This is an application to receive documents filed by the petitioner.

No objection. Heard. Allowed.

I.A.No.1/2023

This is an application filed by the writ petitioner seeking direction to the respondents to implement inter company customer transfer guidelines, following the judgment in W.P.(C) Nos.26014/2019 and 22449/2022, at the earliest.

Having heard respective counsel across the Bar, there will be a direction to the respondent Oil Company to submit before this Court the time required for implementing the guidelines issued for the purpose, within the State.

Post after two weeks."

5. Today, when these writ petitions came up for consideration, the learned counsel appearing for the Oil Companies submitted that the implementation is underway. But, there are some technical problems, which they will cure immediately.

In the light of the above submissions, I think these writ petitions can be disposed of directing the Oil Companies to implement Ext.P2 guidelines within a time frame. Therefore, these writ petitions are disposed of with the following direction:-

- i) Respondents 2, 4 and 6 in these writ petitions are directed to implement Ext.P2 guidelines, as expeditiously as possible, at any rate, within four months from the date of receipt of a certified copy of these writ petitions.
