This writ petition is filed by Ulliyeri Grama Panchayat seeking for a direction to quash the impugned order 1775/2016 dated 25.2.2016 of the Hon'ble Ombudsman for Local Self Government Institutions and the order in HRMP No.2832/17/KKD dated 22.8.2017 of the Hon'ble Human Rights Commission, Kerala. Petitioner has also sought for a direction to the respondents 3, 5, 6 and 7 not to direct or compel the petitioner to pay the enhanced rent on the basis of an application filed by 4th respondent land lord.
