Prayer in CrI.R.C(MD)No.766 of 2021:-

This Criminal Revision has been filed under Section 397 r/w 401 of Criminal Procedure Code, to call for the records of the Principal Sessions Judge, Ramanathapuram, in CrI.M.P.No.1512 of 2021, dated 11.08.2021 and modify the condition No.3 of Rs.60,000/- as costs by way of an individual/collective Deposit in favour of the District Legal Services Authority, Ramanathapuram.

This Criminal Miscellaneous Petition has been filed to modify the condition imposed on the petitioner on 11.08.2021 in CrI.M.P.(MD).No.1512 of 2021, on the file of Principal District and Sessions Judge, Ramanathapuram.

2. On the side of the petitioner, it is stated that learned Principal District and Sessions Judge, Ramanathapuram directed to execute a bond for a sum of Rs.1 lakh with two sureties each, in which, one surety shall be blood relative of the petitioner. The petitioner is not able to comply with the condition, which is onerous. Hence, prays to modify the same.

3. On the side of prosecution, there is no objection raised to modify the said condition.

4. Considering the nature of offence, the condition No.2 in CrI.M.P(MD) No.1512 of 2021, dated 11.08.2021 is modified to the effect that the petitioner shall execute a bond for a sum of Rs.1 lakh with two sureties each for a likesum to the satisfaction of Principal District and Sessions Judge, Ramanathapuram. The other conditions remained unaltered.
