Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition,the High Court may be pleased to grant stay of all further proceedings including the arrest of the Petitioners/Accused A1 to A3, in Crime No. 308/2021, dated. 22.12.2021. and same was registered U/Sec. 447, 427, 504, 506 r/w 34 of IPC and 3(1)(f), 3(1)(r)(s) of SC/ST (POA) Act, 2015, and said false crime was registered by the SHO, Huzumagar. Police Station, Huzumagar Town, Suryapet District, TS, against the Petitioners/Accused A1 to A3 herein, pursuant to the false and frivolous compliant of the 2nd respondent herein, pending disposal of the above Criminal Petition.

CRIMINAL PETITION No.503 OF 2022

ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners-accused Nos.1 to 3 seeking to quash the proceedings against them in FIR No.308 of 2021, dated 22.12.2021 on the file of Station House Officer, Huzurnagar Police Station, Suryapet District for the offences under sections 447, 427, 504, 506 r/w 34 of IPC, 3(1)(f) and 3(1)(r)(s) of SC/ST (POA) Act, 2015.

2. On written instructions and as per the e-court case status proceedings learned Additional Public Prosecutor would submit that the charge sheet was filed on completion of investigation and the case was numbered as S.C.No.71 of 2022, hence, the Criminal Petition has become infructuous.

3. Accordingly, this Criminal Petition is dismissed as infructuous. However, the petitioner is at liberty to move a fresh application, in case the cause survives.
