Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to call for records and quash the Crime No.15 of 2023 on the file of the Garidepally Police Station, Suryapet District, against the petitioner/Accused No.7.

I.A. NO: 2 OF 2023

Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to grant stay of all further proceedings including arrest of the petitioner/accused No.7 Crime No.15 of 2023 on the file of the Garidepally Police Station, Suryapet District, pending final disposal of the main Criminal Petition.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri S CHANDRA MOHAN REDDY, Advocate for the Petitioner and the Additional Public Prosecutor on behalf of the Respondent No.1 and None appeared for the Respondent No.2.

The Court made the following: ORDER

CRIMINAL PETITION No.975 OF 2023

ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-Accused No.7 to quash the proceedings against him in FIR No.15 of 2023 on the file of Station House Officer, Garidepalli Police Station, Suryapet District, registered for the offences punishable under Sections 353 and 323 read with Section 34 of Indian Penal Code (for short "IPC").

2. Heard learned counsel for the petitioner -- Accused No.7 and learned Additional Public Prosecutor for the respondent No.1 -- State. Perused the material on record.

3. The case of the 2nd respondent who is the police constable is that one Sont. Sneha and one boy were brought to the police station who married without informing elders and when they were in the police station, the accused allegedly went into the police station and beat them.

4. On perusal of the complaint, there is no specific allegation against this petitioner who is arrayed as Accused No.7. This Court deems it appropriate to direct the Investigating Officer in FIR No.15 of 2023 on the file of Station House Officer, Garidepalli Police Station, Suryapet District, to conclude the investigation without taking any coercive steps against the petitioner – Accused No.7. Further, the petitioner – Accused No.7 shall co-operate with the Investigating Officer as and when required for the purpose of investigation.

5. Accordingly, the Criminal Petition is disposed off.

Miscellaneous applications pending, if any, shall stand closed.
