ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-accused No.2 seeking to quash the proceedings against him in F.I.R No.10 of 2022, on the file of Choppadandi Police Station, Karimnagar District for the offences under sections 294(b), 505(1) and 506 of IPC.


2. On instructions and as per the e-courts case status proceedings learned Additional Public Prosecutor would submit that the charge sheet was filed on completion of investigation and the case was numbered as C.C.No.147 of 2022, hence, the Criminal Petition has become infructuous.

3. Accordingly, this Criminal Petition is dismissed as infructuous. However, the petitioner is at liberty to move a fresh application, in case the cause survives.
