This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners/accused Nos.1 and 3 to quash the proceedings in Spl.S.C.No.24 of 2017 on the file of the VI Additional Metropolitan Sessions Judge, Secunderabad, registered for the offences punishable under Sections 498, 376, 417, 506 of Indian Penal Code and Sections 3 (1) (XII) of SC/ST (POA) Act.

2. Heard learned counsel for the petitioners and learned Additional Public Prosecutor for the respondent-State and perused the record.
3. The crime is of the year 2013 and charge was also filed in the year 2013. The parties have approached this Court seeking permission of this Court to compromise the case. However, this Court refused by order, dated 02.08.2019. The


status of the case in the trial Court is not known. Hence, this Court is not inclined to keep the petition pending.
