ORDER:

The Criminal Petition is filed under Section 482 of the Code of Criminal Procedure (for short Cr.P.C.) by the petitioners/Accused Nos.1, 2, 5 and 6 to quash the proceedings in C.C.No.364 of 2016 on the file of the III Metropolitan Magistrate, Cyberabad at L.B Nagar, registered for the offences punishable under Sections 409, 420, 381, 120-B of Indian Penal Code.

2. Heard learned counsel for the petitioners and learned Additional Public Prosecutor appearing for the respondent-State and perused the record.

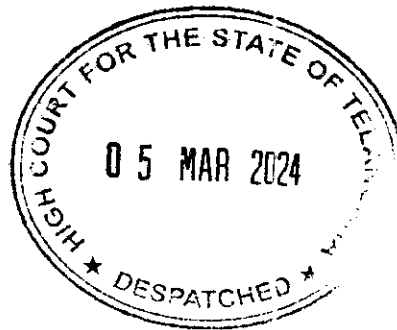
