**CRIMINAL PETITION No.3252 OF 2023**

**ORDER:**

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner-Accused to quash the proceedings against him in Crime No.458 of 2020 pending on the file of the Station House Officer Sircilla Town Police Station, Rajanna Sircilla. The offences alleged against him are under Sections 420 of the Indian Penal Code (for short 'IPC') and Section 13 of TSTAMLA.

2. Heard both sides.
  3. After arguing sometime, learned counsel for the petitioner confines his prayer to direct the police to follow the procedure prescribed under Section 41-A of Cr.P.C. for the reason of the offence alleged against the petitioner is punishable less than seven (07) years.
  4. In view of the aforesaid submission of the learned counsel for the petitioner, this Criminal Petition is disposed of directing the Investigating Officer in respect of Crime

No.458 of 2020 pending on the file of the Station House Officer, Sircilla Town Police Station, Rajanna Sircilla, to strictly follow the procedure laid down under Section 41-A of Cr.P.C. and also the guidelines issued by the Hon'ble Supreme Court in ***Arnesh Kumar v. State of Bihar***<sup>1</sup>. The petitioners shall co-operate with the Investigating Officer by furnishing information and documents as sought by them in concluding the investigation.

Miscellaneous applications pending, if any, shall stand closed.
