Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ order or direction more particularly one in the nature of Writ of Mandamus declaring the action of Respondents is not conducting Survey, demarcation of the Boundaries in respect of the petitioners land admeasuring Ac. 2.15 Gts in the Sy.No. 504/K/7, situated at Palwal village, Maldakal Mandal, Jogulamba Gadwal District as prescribed under the A.P. Survey and Boundaries Act, 1923 as illegal and arbitrary and consequently direct the Respondents to complete the Survey and Demarcation of the Boundaries expeditiously with respect to the petitioner land admeasuring Ac. 2.15 Gts in the Sy.No. 504/K/7, situated at Palwal village, Maldakal Mandal, Jogulamba Gadwal District.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No.3 to consider the application dated 14.07.2022 for immediately conducting Survey and Demarcating the Boundaries with regard to land admeasuring Ac. 2.15 Gts in the Sy.No. 504/K/7, situated at Palwal village, Maldakal Mandal, Jogulamba Gadwal District, as prescribed under the A.P. Survey and Boundaries Act, 1923 forthwith, pending disposal of above writ petition.

WRIT PETITION No.8898 of 2023

ORDER:

Heard learned counsel for the petitioner and learned Assistant Government Pleader for Revenue.

2. The petitioner herein is claiming that she is absolute owner and possessor of land admeasuring Ac.2-15 gts in Sy.No.504/ka/7, situated at Palwal Village, Maldakal Mandal, Jogulamba Gadwal District. In proof of the same, she has filed copies of latest Pattadar passbook and title deed. She has requested respondent No.4 to conduct survey and demarcate the aforesaid land by fixing the boundaries, he has issued two (02) notices dated 28.01.2022 and 19.07.2022 fixing the survey, but he failed to conduct survey. Thereafter, there is no response from him. Therefore, the present Writ Petition.

3. Whereas, learned Assistant Government Pleader for Revenue on instructions would submit that respondent No.4 will conduct and conclude the survey pursuant to aforesaid notices in accordance with law.

4. In view of the said discussion, this Writ Petition is disposed of directing respondent No.4 to conduct survey and demarcate the aforesaid land by fixing the boundaries pursuant to notices dated 28.01.2022 and 19.07.2022 strictly in accordance with law by putting the petitioner and all affected parties on notice and affording them an opportunity. If, respondent No.4 is not inclined to accept the request made by the petitioner, he shall assign specific reasons and pass a reasoned order, communicate copy of the said order to the petitioner. He shall complete the said exercise within 45 working days from the date of receipt of a copy of this order. There shall be no order as to costs.

As a sequel, the miscellaneous petitions, if any, pending in the Writ Petition shall stand closed.
