ORDER:

This writ petition is filed under Article 226 of Constitution of India for the following relief:

"...to issue an appropriate Writ, order or orders or direction more particularly one in the nature of Writ of Mandamus by declaring the action of the official respondent Nos.1 and 2 in not considering and promoting the petitioner to the post of Additional Superintendent of Police (A.R.) Panel year 2022-2023, as per provisional seniority list dated 23.06.2022 as on 01.01.2022 as illegal, arbitrary and violation of Articles 14, 19 and 21 of the Constitution of India and against the principles of Justice"

2. Heard the Learned counsel for the petitioner and Learned Government Pleader for Home appearing for the respondent Nos.1 and 2. With their consent, this Writ Petition is disposed of at the stage of admission itself.
3. In view of the submissions made by the Learned Counsel for the petitioner as well as the Learned

Government Pleader, without going into merits of the case, this Writ petition is disposed of with a direction to the respondents to dispose of the representation filed by the petitioner on 28.01.2023, within eight (8) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
