Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to quash the FIR No.18 /2021 dated 01/03/2021 on the file of The Honourable.II Addl. Judicial Magistrate of F.C.at Huzurabad.

Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to stay all further proceedings and direct the Respondent No.1 not to arrest the Petitioners /Accused No.A7-A9 in FIR No.18 /2021 dated 01/03/2021 on the file of The Honourable.II Addl. Judicial Magistrate of F.C.at Huzurabad, pending disposal of the above Quash proceedings.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri VOOSA RAGHU, Advocate for the Petitioner and the Public Prosecutor on behalf of the Respondent No.1 and of none appeared for the Respondent No. 2.

ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioners who are arrayed as Accused Nos.7 to 9 seeking to quash the proceedings against them in FIR No.18 of 2021 on the file of learned II Additional Judicial Magistrate of First Class, Huzurabad registered for the offences punishable under Sections 379, 498-A read with Section 109 of the Indian Penal Code, Section 4 of Dowry Prohibition Act and Section 3 (1) (r) (s) of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015.

2. On written instructions, learned Additional Public Prosecutor would submit that after completion of investigation in the subject crime, the police filed charge sheet before the Court concerned and Spl. S.C.No.179 of 2022 was assigned. Hence, the prayer sought for in the present petition has become infructuous.

3. Recording the aforesaid submission, the Criminal Petition is dismissed as infructuous. However, the petitioners-Accused are at liberty to move this Court seeking quashment of the proceedings of the charge sheet.
