**WRIT PETITION No.13473 OF 2023**

**ORDER:**

This Writ Petition is filed seeking a writ of mandamus to declare the action of the 2<sup>nd</sup> respondent in not releasing the petitioner's contract carriage Bus bearing No.KA-51-AB-3628 seized in Crime (COR) No.30/2023 inspite of readiness of the petitioner to furnish third party surety is illegal and arbitrary and consequently direct the respondent Nos.2 and 3 to release the petitioner's contract carriage Bus bearing No. and pass such other order or orders.

2. Heard Sri Ch.Ravinder, learned counsel for the petitioner and learned Government Pleader for Prohibition and Excise.

3. Learned counsel for the petitioner submitted that the issue raised in the present Writ petition is squarely covered by the order passed by this Court in W.P.No.5480 of 2021 dated 09.03.2021.

4. Learned Government Pleader for Prohibition and Excise did not oppose the said submission.

5. Therefore, for reasons alike, this Writ Petition is also disposed of at the admission stage with a direction to the respondents to release the bus bearing No. KA-51-AB-3628 in favour of the petitioner subject to his furnishing a Fixed Deposit Receipt (FDR) for a sum of Rs.1,00,000/- (Rupees One Lakh Only) in favour of respondent No.2-the Deputy Commissioner, Prohibition and Excise Department, Medchal-Malkajgiri District. The petitioner/Owner of the bus shall also furnish an undertaking that he will not alienate or change physical feature of the subject vehicle. Respondent No.2 shall write to the R.T.A. authority not to transfer the vehicle in favour of any third party without clearance from the Excise Department. Needless to say, release of the bus is subject to orders that shall be passed by respondent No.2 pursuant to the enquiry to be conducted under the provisions of the Excise Act. No order as to costs.

Miscellaneous petitions, if any, pending shall stand closed.
