Property House no. 3-41-35, SCB -No. 4-10-030, Adm. 333 Sq. yds, with built up area of 100, Sq.ft, of ACC Sheets, situated at Horse stables, West Marredpally, Secunderabad Cantonment, Secunderabad - T.S, as they are the owners and are in possession of the property.
