**COMMOM ORDER:**

With the consent of both the parties, these Writ Petitions are disposed of by way of this common order since the issue raised in these writ petitions is one and the same.

2. For the sake of convenience, the facts in writ petition No.13514 of 2023 are discussed herein.

3. Writ petition No.13514 of 2023 is filed by the petitioner under Article 226 of the Constitution on India seeking the following relief:

*"...to issue a Writ Order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of respondents particularly respondent No.s 4 and 5 in not issuing any notice and directing the petitioner immediately to remove / demolish the house bearing No 3- 61 constructed in Sy No 152 admeasuring 150 Sq yards and otherwise threatening to demolish the house constructed by the petitioner herein in Sy No 152 admeasuring 150 Sq yards situated at Ilapur Village and Gram Panchayat Ameenpur Mandal Sangareddy District under the limits of 4th respondent Gram Panchayat without having any*

*authority without issuing any prior notice is illegal arbitrary and violation of Article 14 and 300-A of Constitution of India apart from violation of principles of natural justice and consequently direct the respondents to not to demolish the residential building bearing house No 3-61 in Sy No 152 situated at Ilapur Village and Gram Panchayat Ameenpur Mandal Sangareddy District...."*

4. Heard Mr.Y.Vijaya Bhasker Reddy, learned counsel for the petitioner, learned Government pleader for Panchayat Raj for respondent Nos.1 to 3 and Mr.R.Chandra Shekar Reddy, learned Standing Counsel for Gram Panchayat, for respondent Nos.4 and 5.

5. Learned counsel for the petitioner contended that petitioner is the absolute owner and possessor of open plot admeasuring 150 Sq.yds in Survey No.152, situated at Ilapur Village and Gram Panchayat, Ammenpur Mandal, Sangareddy District; the grievance of petitioner is that the respondents, without issuing any notice to the petitioner, are trying to demolish the house of the petitioner; and therefore, prayed this Court to pass appropriate orders in the writ petition by directing the respondents to not to dispossess and demolish the house of petitioner without following due process of law.

6. On the other hand, Mr.R.Chandra Shekar Reddy, learned standing counsel for Gram Panchayat appearing for respondent Nos.4 and 5 contended that the respondents would not dispossess the petitioner from his land and they would also not demolish the structures raised by the petitioner without following due process of law.

7. In view of above submissions, this Court is of the view that the present writ petition as well as other writ petitions can be disposed of by directing the respondents not to dispossess or demolish the structures raised by the petitioner without following due process of law.

8. With these observations, all these writ petitions are disposed of. No costs.

9. As a sequel, miscellaneous applications pending, if any, in these writ petitions, shall stand closed.
