ORDER:

Heard Ms. K.V.Rajasree, learned counsel appearing for the petitioner and Sri.Gadi Praveen Kumar, learned Deputy Solicitor General of India appearing for respondents. Perused the record.

2. This Writ Petition is filed to declare the action of respondent No.2 in not reissuing/renewing the passport to the petitioner on the alleged ground that her father has not signed the application for reissue/renewal of the passport bearing No.N5602867 and declare the same as illegal and arbitrary.

3. Learned Deputy Solicitor General of India has placed on record the written instructions of respondent No.2, wherein it is specifically stated that new Passport has been issued vide passport bearing No.Y5283441 dated 24.05.2023 valid upto 23.05.2028 and the same

has been dispatched by speed post to the address of the petitioner as mentioned in the application.

4. In view of the fact that the grievance of the writ petitioner is redressed, accordingly, this Writ Petition is closed. There shall be no order as to costs.

As a sequel, the miscellaneous petitions, if any, pending in the Writ Petition shall stand closed.
