ORDER:

1. The present Civil Revision Petition has been directed against the docket order, dated 11.05.2023, where under a revision was made to the Court below by the learned counsel for the petitioner that respondent's counsel is not co-operating for cross examination of PW1 through commission. Recording the same, the Advocate Commissioner is directed to file report by 06.06.2023. Aggrieved by the same, the present revision is filed.

2. The main grievance of the revision petitioner is that the petitioner filed an interim maintenance application and that application is not disposed of because of non-cooperation of the respondent herein, who filed divorce petition and she is insisting for early disposal of the divorce petition, pending interim application. It is also submitted that the petitioner's counsel was threatened

and as such, they could not proceed with the examination.

3. Without expressing any merits touching the case, this Court is inclined to dispose of this revision petition by dispensing with the notice to the respondent.

4. Accordingly, this Civil Revision Petition is disposed of with a direction to the Court below to consider the interim maintenance application, which is pending, basing on the available documents produced by the respondent, within 15 days from the date of receipt of a copy of this order, without waiting further.

5. The petitioner is not entitled to stall the main proceedings and she shall co-operate for the disposal of the main FCOP. The time fixed by the Court below for submitting the Advocate Commissioner's report is extended till 23.06.2023. In the meanwhile, the interim maintenance application shall also be considered as directed.

Pending miscellaneous applications, if any, shall stand closed. However, there shall be no order as to costs.
