CONTEMPT CASE No.785 of 2020

ORDER:

1. None appears for the petitioner.
2. This Contempt case is filed alleging willful and deliberate disobedience of the order dated 28.10.2019 in W.P.No.15447 of 2009.
3. Vide aforesaid order, this Court allowed the said Writ Petition, in terms of the order dated 02.12.2014 in W.P.No.18213 of 2009, by setting aside the impugned orders of the State Government, declaring that the said recommendations cannot form the basis for initiating any action against the petitioner. However, it is open for the respondent-authorities to conduct enquiry after giving notice and opportunity of being heard to the petitioner.
4. Learned Deputy Solicitor General of India appearing for respondent submits that in compliance with the order, an opportunity of hearing was afforded to the petitioner. Vide proceedings dated 29.07.2020, the respondent has rejected the claim of the petitioner herein.

Challenging the said proceedings, petitioner has filed W.P.No.14471 of 2020 and the same was also disposed of by this Court on 12.10.2022.

5. In view of the same, this Contempt Case is closed.

As a sequel, the miscellaneous petitions, if any, pending in the Writ Petition shall stand closed.

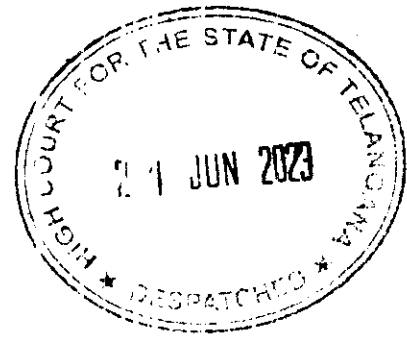
