Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to call for the records relating to Crime No. 248 of 2023 on the file of the Police Station, Inthezargunj, Warangal, Warangal district, and quash the proceedings in Crime No. 248 of 2023 and pass such other order or orders as this Hon'ble Court may deem fit and proper in the circumstances of the case.

Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to stay all further proceedings in Crime No. 248 of 2023 on the file of the Police Station, Inthezargunj, Warangal, Warangal district, pending disposal of the criminal petition and pass such other order or orders as this Hon'ble Court may deem fit and proper in the circumstances of the case.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri.A.PRABHAKAR RAO, Advocate for the Petitioner and of the Assistant Public Prosecutor for the State of Telangana on behalf of the Respondent No.1 and for the Respondent No.2 none appeared.

The Court made the following: ORDER

**CRIMINAL PETITION No.5806 OF 2023**

**ORDER:**

This Criminal Petition is filed under Section 482 of Code of Criminal Procedure (for short 'Cr.P.C.') by the petitioner/accused to quash the proceedings in FIR No.248 of 2023 on the file of the Station House Officer, Inthezargunj Police Station, Warangal, registered for the offences under Section 506 of the Indian Penal Code (for short 'IPC') and Section 3(1)(r)(s) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 2015.

2. Heard learned counsel for the petitioner and Sri S.Ganesh, learned Assistant Public Prosecutor for respondent - State. Perused the record.

3. Taking into consideration the fact that all the offences alleged against the petitioner are punishable less than seven (07) years, this Court deems it appropriate to direct the petitioner/accused to appear before the investigating officer on or before 10.07.2023 between 02:00 p.m. and 04:00 p.m. and the investigating officer is directed to follow the procedure laid down under Section 41-A Cr.P.C and also the guidelines formulated by the Hon'ble Supreme Court in **Arnesh Kumar v.**

**State of Bihar**<sup>1</sup> scrupulously. However, the petitioner/accused shall co-operate with the Investigating Officer as and when required by furnishing information and documents as sought by him in concluding the investigation.

4. Accordingly, the Criminal Petition is disposed of.

Pending miscellaneous applications, if any, shall stand closed.

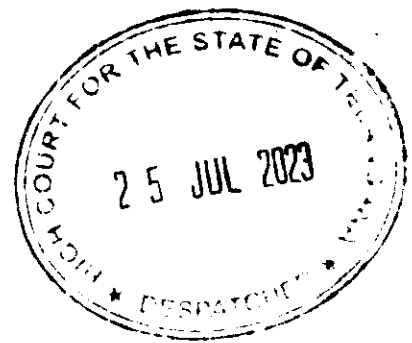
