Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to direct the court below i.e., Principal special Judge for SPE and ACB cases-cum-IV Additional Chief Judge, City Civil Court, Hyderabad to return the petitioners passport bearing No. N-0229376 which is deposited in CC No. 18 of 2012 by permitting the petitioner herein to visit/travel USA for a period of 6 months, pending disposal of the CC No. 18 of 2012 on the file of the court of the Principal Special Judge for SPE and ACB cases-cum-IV Additional Chief Judge, City Civil Court, Hyderabad in the interest of justice.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri M J SIVA RAMA KRISHNA, Advocate for the Petitioner and the SRI VIDYA SAGAR RAO CHITNENI ( SC SPL PP FOR ACB) on behalf of the Respondent.

ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure, 1973 (for short 'Cr.P.C.') by the petitioner, /accused to direct the Court below to return the petitioner passport bearing No.0229376 which is deposited in C.C.No.18 of 2012 by permitted the petitioner herein to visit/travel USA for a period of six months.

2. Heard learned counsel for the petitioner and learned counsel for the respondent-State and perused the record.

3. This application was filed on 16.10.2019 praying this Court to permit the petitioner to travel to USA for a period of six (06) months. At this length of time, the cause would not survive. Hence, I do not find it appropriate to keep this petition pending.

4. Accordingly, this Criminal Petition is disposed of. However, this petitioner is at liberty to approach the Court below, if necessity to travel arises.

Miscellaneous applications pending, if any, in this criminal petition, shall stand closed.

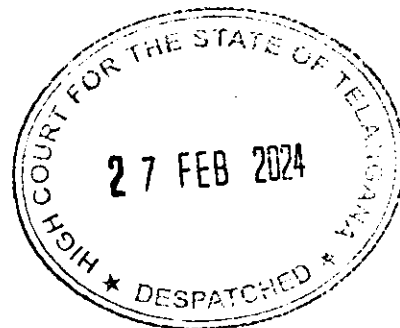
