Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of writ of Mandamus declaring the inaction of the Respondent No.2 considering the petitioner for counseling and admission into Post Graduate Dental courses wider Management quota MQ-1 & MQ-2, MQ-3 (NRI Quota) for the academic year 2023-24 in allowing the Petitioner is illegal, arbitrary and unconstitutional and consequently direct the respondents to consider and include the name of the petitioner in the next round of counseling and admission into

Post Graduate Dental courses under Management quota MQ-1 & MQ-2, MQ-3 (NRI Quota) for the academic year 2023-2024.

ORDER: *(Per the Hon'ble the Chief Justice Alok Aradhe)*

Heard Mr. Rajagopallavan Tayi, learned counsel for the petitioner; Mr. N.Praveen Kumar, learned Government Pleader for Medical, Health and Family Welfare for respondent No.1; and Mr. A.Prabhakar Rao, learned Standing Counsel for Kaloji Narayana Rao University of Health Sciences (hereinafter referred to as 'the University') representing respondent No.2.

2. The Writ Petition is admitted for hearing. With the consent of the parties, the same is heard finally.

3. In this Writ Petition, the petitioner, *inter alia*, seeks a direction to the respondents to consider the request of the petitioner to receive her application for admission to Post Graduate Medical Course for the academic year 2023-24 against Management Quota seats under Category 1, 2 and 3.

4. Learned counsel for the petitioner submitted that the petitioner due to online technical glitch, she could not register for PG counselling within time. He further submitted that the petitioner be granted liberty to submit a representation to the University and the University be directed to decide the said representation in a time bound manner.
5. Learned Standing Counsel for the University submitted that the last date of registration was 16.08.2023 and thereafter, merit list has been prepared, which shall be published at the time of indicating the web option. However, it is fairly submitted by him that, in case the petitioner submits a representation, the same shall be dealt with by the University in accordance with law.
6. In view of the aforesaid submission and in the peculiar facts of the case, the Writ Petition is disposed of with liberty to the petitioner to submit a representation before the University with regard to her grievance. Needless to state that in case such a representation is made, the University shall decide the same

within a period of two (02) days thereafter. It is made clear that this Court has not expressed any opinion on the merits of the matter. No order as to costs.

As a sequel, miscellaneous petitions, pending if any, stand closed.

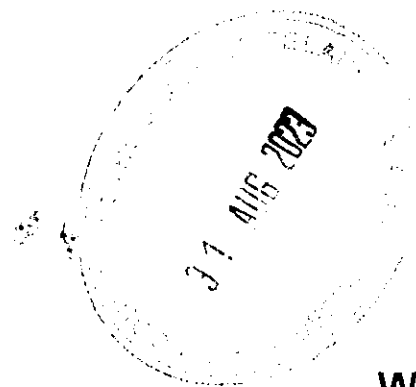
