**THE HON'BLE Dr. JUSTICE CHILLAKUR SUMALATHA**

**WRIT PETITION No.24238 OF 2023**

**ORDER:**

Heard Sri Kondadi Ajay Kumar, learned counsel for the petitioners, Ms.P.Sumalatha, learned Assistant Government Pleader for Fisheries, who is representing respondent Nos.1, 2 and 4 and learned counsel for respondent No.5.

2. This writ petition is filed aggrieved by the inaction of the respondent Nos.1 to 4 in considering the representation of the petitioners dated 16.08.2023.

3. Making his submission with regard to the merits of the matter, learned counsel for the petitioners contends that the petitioners were requesting all the concerned authorities to provide membership to them in Rangapur Primary Fishing Co-operative Society Limited, i.e., 5<sup>th</sup> respondent's society, however, the request of the petitioners is not considered till now.

4. Learned counsel for the petitioners states that very recently i.e., on 16.08.2023, the petitioners submitted another representation to the District Collector, Jagtial i.e., respondent

No.3 herein, but the same is kept pending till now without passing any orders. Learned counsel for the petitioners submits that no further orders in this writ petition are required except to direct respondent No.3 to enquire into the matter basing on the representation of the petitioners and to take a decision.

5. Neither learned Assistant Government Pleader for Fisheries nor learned counsel appearing for respondent No.5 raised objection for grant of such a relief. Also, the relief sought for appears justifiable in the light of the material that is produced on record, including the copy of the representation, dated 16.08.2023. Therefore, this Court considers it desirable to order the District Collector, Jagtial to enquire into the issue and pass appropriate orders.

6. Resultantly, the Writ Petition is disposed of with the following direction:

Respondent No.3-District Collector, Jagtial, is directed to enquire into the representation of the petitioners dated 16.08.2023 and pass appropriate orders strictly in accordance with law, within a period of four(4) weeks from the date of receipt of a copy of this order. The decision taken be



communicated to the petitioners. There shall be no order as to costs.

Miscellaneous Petitions, if any, pending in this Writ Petition shall stand closed.
