ORDER:

1. The present Criminal Petition is filed under Section 432 of the Code of Criminal Procedure (in short 'Cr.P.C') by the petitioner-accused No.5 seeking to quash the criminal proceedings in Crime No.174 of 2021, on the file of Bhanor Police Station, Sangareddy, registered for the offence punishable under Section 8(c) read with Section 22 (C) of the Narcotic Drugs and Psychotropic Substances Act, 1985.
2. On instructions, learned Additional Public Prosecutor has submitted that subsequent to filing of this petition, the police have concluded the investigation and filed charge sheet before the Court concerned and the same was numbered as S.C.No.70 of 2022.
3. Recording the above submission, the Criminal Petition is dismissed as infructuous, leaving it open to the petitioner to challenge the proceedings in S.C.No.70 of 2022, if he intends to do so. Miscellaneous petitions pending if any shall stand closed.
