This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri T LAKSHMI NARAYANA ,Advocate for the Petitioner and the Public Prosecutor (TG) on behalf of the Sole Respondent.

The Court made the following: ORDER

CRIMINAL PETITION No.10601 of 2023

ORDER:

1. This Criminal Petition is filed under Section 438 of Cr.P.C. by the petitioner/Accused seeking bail in the event of his arrest in connection with Crime.No.193 of 2023 on the file of Haliya Police Station, Nalgonda District, registered for the offence under Section 307 of IPC.
2. Heard learned counsel for the petitioner and learned Assistant Public Prosecutor for the respondent-State and perused the record.
3. The allegation against the petitioner is that on 30.09.2023 during Ganesh immersion procession, altercation took place between the husband of the *de-facto* complainant and the petitioner, during which this petitioner slapped her husband and abused her and attacked them with iron rod.
4. Learned counsel for the petitioner submits that the allegations leveled against the petitioner are false and baseless.
5. In view of the above facts and circumstances of the case, this Court deems it appropriate to direct the petitioner to surrender before the Court below and file an application seeking bail. On filing such application, the Court below shall consider the said

application and dispose off the same on the very same day on merits.

6. With the said observation, this Criminal Petition is disposed off. Miscellaneous applications, if any pending in this criminal petition, shall stand closed.
