Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ Order or Orders, more in the nature of Writ of Mandamus declare the impugned Proc.ES/ES/WA/WARA/SCAS/0173 dt.22-12-2021 issued by the 5<sup>th</sup> respondent allotting to Warangal district contrary to petitioner's option exercised to Hanmakonda district under spouse category as per Guideline 23 proviso of G.O.Ms.No.317 dt.06.12.2021 and not implementing Govt.Memo.No.1655/SPD-I/2021-8 dt.24-12-2021 with regard to allotment of spouse category candidates despite availability of vacancies in Hanmakonda dist while implementing and allotting spouse category candidates in other districts as per the above memo is clearly illegal, arbitrary, discriminatory and unjust and set aside the same and consequently declare that the petitioner is entitled to be re-

allocated to Hanmakonda district under spouse category as per option with all consequential benefits.

**IA NO: 1 OF 2023**

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the grievance of the petitioner for reallocation to Hanmakonda district under spouse grounds by disposing of appeal dt.24-12-2021 and dt.28-01-2023 pending disposal of the above writ petition.

**WRIT PETITION No.30264 of 2023**

**ORDER:**

This Writ Petition is filed seeking the following relief:

*“...to issue a Writ Order or Orders more in the nature of Writ of Mandamus declare the impugned Proc.ES/ES/WA/WARA/SCAS/0173, dt 22.12.2021 issued by the 5th respondent allotting to Warangal district contrary to petitioners option exercised to Hanmakonda district under spouse category as per Guideline 23 proviso of G.O.Ms.No.317, dt 06.12.2021 and not implementing Govt. Memo No.1655/SPDI/20218, dt 24.12.2021 with regard to allotment of spouse category candidates despite availability of vacancies in Hanmakonda dist while implementing and allotting spouse category candidates in other districts as per the above memo is clearly illegal, arbitrary, discriminatory and unjust and set aside the same and consequently declare that the petitioner is entitled to be reallocated to Hanmakonda district under spouse category as per option with all consequential benefits and to pass....”*

2. Learned counsel for the petitioner submitted that the petitioner has submitted an appeal dated 24.12.2021 and a representation dated 28.01.2023 for change of new local cadre from Warangal District to Hanmakonda District on spouse ground as per the G.O.Ms.No.371 dated 06.12.2021. The grievance of the petitioner is that respondents have not considered the same so far and is seeking a direction to the respondents to consider the same.

3. Since the appeal and representation of the petitioner are pending from longtime, this Court deems it fit and proper to direct the respondents to consider the appeal dated 24.12.2021 and pass appropriate orders thereon in accordance with law within a period of four (04) weeks from the date of receipt of a copy of this order.

4. With the above directions, the Writ Petition is disposed of at the admission stage. There shall be no order as to costs.

Miscellaneous petitions, if any, pending in this Writ Petition, shall stand closed.
