**ORDER.**

Heard Mr. Shiv Rohan Singh, learned counsel for the applicant and Mr. Ravinder Reddy Muppu, learned counsel for the respondent.

2. This application under Section 11(6) of the Arbitration and Conciliation Act, 1996 (briefly 'the A&C Act') has been filed seeking appointment of sole arbitrator to resolve the dispute between the parties.

3. The applicant was issued work order dated 08.09.2020. Admittedly, dispute has arisen between the parties. Clause 35 of the Tender Document contains an arbitration clause, which reads as under:

Arbitration: In the event of any dispute or difference arising out of the terms and conditions laid down in this tender, the same shall be referred to the Arbitrator appointed by the Dean. The procedure of the Arbitration will be governed by the provision of Arbitration Act,

1996 as amended and rules framed therein  
under.

4. Learned counsel for the respondent submits that he has  
no objection for appointment of a sole arbitrator.

5. Therefore, Mr. B.Gautam Prasad, retired Principal  
District and Sessions Judge, Suryapet (resident of Pavanapuri  
Colony, Karmanghat, # 8-4-31/1, Saroornagar, Ranga Reddy  
District, Hyderabad), is appointed as sole arbitrator to  
adjudicate the dispute between the parties.

6. Parties shall appear along with a copy of this order  
before the Arbitrator on 27.01.2024 at 11:00 a.m.

7. Accordingly, the Arbitration Application is disposed of.  
No costs.

8. Office to communicate a copy of this order to the  
learned Arbitrator.

As a sequel, miscellaneous petitions, pending if any,  
stand closed.
