**MEMORANDUM OF COMPROMISE**

1. That the Appellant filed the present Appeal in OSA No. 43 of 2015 assailing the Order dated 25-08-2015 passed by the Learned Company Court Judge passed in Company Petition No. 159 of 2013 dismissing the Company Petition filed by the Appellant at the stage of admission and the Respondent is contesting the present appeal.
2. That during the pendency of the present appeal the petitioner/Appellant and the Respondent, in order to put quietus to the litigation, have settled the monetary claims out of the court.

5. That the Appellant states that hereinafter, the Appellant will not have any claim against the Respondent with respect to the claims involved in the present appeal.

As the claim of the Appellant in the present appeal is settled and discharged the present appeal filed by the Appellant may be dismissed as withdrawn without costs in the interest of justice. *For Arcom Medical Devices P.*
