Prayer in the present petition was for seeking issuance of directions to respondent No.1 to decide the pending Appeal No. 507/RGSH of 2022 dated 06/07.12.2022.

2. Reply on behalf of respondents has been filed today in Court wherein it is averred that vide notice dated 13.12.2022, the parties were required to appear before the authority on 02.02.2023, however, the petitioner himself sent an e-mail showing his personal difficulty to appear whereupon the matter was adjourned to 25.05.2023 and due to old cases and prior engagements, the matter could not be taken up and was adjourned to 13.06.2023. The same could not be heard even on that date due to paucity of time whereupon the hearing has been deferred to 12.12.2023.

3. Counsel for the petitioner contends that the election of the society is now schedule for 29.10.2023 but the hearing of the grievance is now posted for 12.12.2023.

4. Counsel appearing on behalf of the respondent-State contends that let the petitioner move an appropriate application for seeking pre-ponement of the date of hearing already fixed and that on any such application being so moved, the matter will be taken up on an earlier date for adjudication of the main appeal/the application for any interim relief.

5. Counsel appearing on behalf of respondents No.4 and 5 has no objection to the above said suggestion.

6. Considering that all the parties are agreeable to the appeal be pre-poned from 12.12.2023, the present petition is disposed of, without commenting on the merits of the instant case and with the consent of the parties, pre-poning the date of hearing fixed before the Registrar General of Societies, Haryana from **12.12.2023 to 05.10.2023.**

7. The parties shall appear before the Registrar General on the above said date whereupon the Registrar General shall proceed further in the matter and decide the application for interim/the appeal, as is feasible, expeditiously and preferably before the date fixed for holding of elections.

The writ petition is disposed of.
