For brevity, facts of Writ Petition (S/S) No. 322 of 2023 are being referred herein.</p> <p>After due selection, petitioner was appointed as Store Keeper-cum-Clerk on contractual basis in AIIMS, Rishikesh vide order dated 27.7.2015. Petitioner is serving continuously as such in AIIMS, Rishikesh ever since his initial appointment. Grievance raised by petitioner is against the change of his status as, according to him, he was directly appointed by AIIMS, Rishikesh and he worked till 2018, however, his status was abruptly changed to an outsourced employee w.e.f. 01.12.2018, without any just reason.</p> <p>Learned Counsel for the petitioner contends that change of petitioner's status from contract employment to outsourced employee amount to unfair labour practice, as it has been done in order to deny his legal rights. Various other contentions have been raised by learned Counsel for the petitioner against change of petitioner's status to outsourced employee.</p> |

| | | | <p>Mr. Rakesh Thapliyal, learned Deputy S.G. appearing for AIIMS, Rishikesh, very fairly submits that although petitioner along with other similarly situated employees has made a representation, however, since the same is not addressed to the competent authority, therefore, he may be directed to make representation to Director, AIIMS, Rishikesh. Mr. Thapliyal submits that if petitioner makes representation to the competent authority, the same shall be considered sympathetically.</p> <p>Accordingly, writ petitions are disposed of by permitting petitioners to make separate representation to Director, AIIMS, Rishikesh and if they make such representations within two weeks from today, Director, AIIMS, Rishikesh shall look into the grievance raised by petitioners and take decision within eight weeks thereafter.</p> <p>(Manoj Kumar Tiwari, J.) 28.02.2023</p> <p><i>Arpan</i></p> |
