### **HON'BLE MR. JUSTICE ANOOP KUMAR DHAND**

#### **Order**

**28/02/2023**

Hon'ble Apex Court in the case of **Ex-Capt. Harish Uppal vs Union Of India & Anr., reported in 2003 (2) SCC 45** has held that the Court is under an obligation to hear and decide the cases brought before it and it cannot shirk that obligation only because the lawyers have decided to abstain from the judicial work.

These petitions are pending before this Court since 1997 i.e. last more than 25 years. Looking to the controversy involved in this case, this Court thought it proper to peruse the file and decide the matter on merits.

Since a common question of law and fact is involved in all these petitions, hence all petitions are decided by this common order.

For deciding the controversy in these petitions, the facts mentioned in S.B. Civil Writ Petition No. 6742/1997 are taken into consideration.

As per the contents of this petition, the petitioner was serving as Lab Assistant in the pay scale of Grade-III since 1992 but thereafter, he was declared surplus and was ordered to absorb as Teacher Grade-III in the Education Department.

It appears that vide order dated 10.10.1997 a decision was taken by the State respondents to declare the post of Lab Assistant as Surplus and all persons who were working on the said post were ordered to be absorbed on the post of Teacher Grade-III in the same pay scale.

Feeling aggrieved and dissatisfied by the aforesaid order, instant petition has been filed by the petitioner with the following prayer.

"It is, therefore, prayed that this Hon'ble Court will be pleased to accept this writ petition and further be pleased to issue a writ, order or direction to the following effects.

I. to direct the respondent State to not to declare the petitioner as surplus on the post of Lab. Assistant.

II. To direct the respondent that if the petitioner is declared surplus then he should be adjusted absorbed and appointed as Jr. Engineer (Civil) or surveyor or Draftsman in the Department of PWD and Irrigation or any else in the State of Rajasthan.

III. To pass any other order which is just and proper and in the favour of the petitioner. The writ petition be allowed."

Perusal of the file indicates that no interim order was passed by this Court and these petitions were submitted against the impugned order almost 25 years back. It appears that by efflux of

time, these petitions have become infructuous and the relief sought in these petitions cannot be granted to the petitioners after passing of more than 25 years.

In view of the factual aspect of the matters, these petitions are rendered as infructuous, hence the same are dismissed as having become infructuous.

Stay applications and all pending application(s), if any also stand dismissed.

Before parting with this order, liberty is granted to the petitioners to move an application for revival of the petition(s) in case, any grievance still survives/subsists.

A copy of this order be placed in each of the connected matters.
