1. These bail applications have been filed by petitioners under Section 439 Cr.P.C. in connection with FIR No. 205/2023 registered at Police Station Pradhan Arakshi Kendra, Anti Corruption Bureau, Jaipur for offences under Sections 7, 7A and 11 of Prevention of Corruption Act, 1988 .



2. Learned Public Prosecutor has opposed the bail applications.
3. Heard learned counsel for petitioners as well as learned public prosecutor and perused the material available on record.
4. Having considered the fact that it is not a case of red handed trap against petitioner and the charge-sheet has been filed, petitioners are in custody since 28.07.2023 and conclusion of trial will take its considerable time, but without commenting on merits of the case, this Court deems it just and proper to release these petitioners on bail.
5. Accordingly, the bail applications are allowed and it is ordered that the accused-petitioners **(1) Vedprakash Sharma @ Akshay S/o Ashok Kumar Sharma and (2) Smt. Priyanka Sharma @ Sonu W/o Ashish Sharma** shall be released on bail provided each of them furnishes a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial Judge for their appearance before the court concerned on all the dates of hearing as and when called upon to do so.
