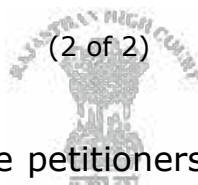

These applications for bail under Section 439 Cr.P.C. have been filed by the petitioners who have been arrested in connection with F.I.R. No.47/2023 registered at Police Station Ramsinghpur, District Sri Ganganagar, for the offences punishable under Sections 323, 341, 382, 395 and 143 IPC.

Heard learned counsel for the petitioners and learned Public Prosecutor. Perused the material available on record.



Learned counsel for the petitioners submitted that the offences alleged to have been committed by the petitioners are triable by court of Magistrate. Co-accused Surendra Kumar (Bail Application No.4790/2023) has already been enlarged on bail by this Court vide order dated 27.04.2023. The petitioners are in judicial custody and the trial of the case will take sufficiently long time, therefore, the benefit of bail may be granted to the accused-petitioners.

Per contra, learned Public Prosecutor has opposed the bail applications.

Having considered the rival submissions, facts and circumstances of the case, without expressing any opinion on merits/demerits of the case, this Court is of the opinion that the bail applications filed by the petitioners deserve to be accepted.

Consequently, these bail applications under Section 439 Cr.P.C. are allowed. It is ordered that the accused-petitioners **(1) Rajesh S/o Bhera Ram and (2) Sonu S/o Krishan Lal** arrested in connection with F.I.R. No.47/2023 registered at Police Station Ramsinghpur, District Sri Ganganagar, shall be released on bail, if not wanted in any other case, provided each of them furnishes a personal bond of Rs.50,000/- (Rupees Fifty Thousand) and two sureties of Rs.25,000/- (Rupees Twenty Five Thousand) each, to the satisfaction of learned trial court, for their appearance before that court on each & every date of hearing and whenever called upon to do so till completion of the trial.
