**Order**

This application for bail under Section 439 Cr.P.C. has been filed by the petitioners who have been arrested in connection with F.I.R. No.201/2023 registered at Police Station Jawahar Nagar, District Sri Ganganagar, for offence under Section 8/15 of the NDPS Act.

Heard learned counsel for the petitioners and learned Public Prosecutor. Perused the material available on record.

Learned counsel for the petitioners submits that the contraband recovered from the petitioners is below commercial quantity. No case of similar nature is pending against the petitioners. Learned counsel submitted that the petitioners are in judicial custody and the trial of the case will take sufficiently long

time, therefore, the benefit of bail may be granted to the accused-petitioners.

Per contra, learned Public Prosecutor has opposed the bail application.

Having considered the rival submissions, facts and circumstances of the case, without expressing any opinion on merits/demerits of the case, this Court is inclined to enlarge the petitioners on bail.

Consequently, the bail application under Section 439 Cr.P.C. is allowed. It is ordered that the accused-petitioners **(1) Devendra @ Bittu S/o Mahaveer Bishnoi and (2) Rajapl Bishnoi S/o Sh. Hanuman Bishnoi** arrested in connection with F.I.R. No.201/2023 registered at Police Station Jawahar Nagar, District Sri Ganganagar, shall be released on bail, if not wanted in any other case, provided each of them furnishes a personal bond of Rs.1,00,000/- and two sureties of Rs.50,000/- each, to the satisfaction of learned trial court, for their appearance before that court on each & every date of hearing and whenever called upon to do so till completion of the trial.
