- 1. Heard Sri Janardan Singh, learned counsel for the petitioner and Sri Vivek Kumar Shukla, learned Addl. Chief Standing Counsel for the State-respondents no.1 to 5.
- 2. In view of the proposed order, notice to opposite party no.6 is hereby dispensed with.
- 3. By means of this petition, the petitioner has mainly prayed that opposite parties no.1 to 5 may be directed to take appropriate action against opposite party no.6 in respect of the illegal possession over the ancestral agricultural land of the petitioner i.e. Khasra Nos.10, 11, 12, 13, 14, 17, 18, 19, 20 relating to Khata No.203 situated in Village- Pansara Shailab, Pargana- Shailab Rudauli, Tehsil- Ram Sanehighat, District-Barabanki.
- 4. Learned counsel for the petitioner has submitted that for redressal of the aforesaid grievance, the petitioner has preferred representation to the competent authority, but to no avail. Learned counsel for the petitioner has also submitted that the petitioner may be permitted to prefer a fresh representation before opposite party no.4 and this Court may direct opposite party no.4 to pass appropriate order strictly in accordance with law.
- 5. Learned counsel for the opposite parties has no objection if direction for disposal of the representation is issued.
- 6. Therefore, without entering into merits of the issue, the petitioner is permitted to prefer a fresh representation to opposite party no.4 i.e. Sub Divisional Officer, Tehsil- Ram Sanehighat, District- Barabanki taking all pleas and grounds, which are necessary for disposal of the representation and also enclosing the earlier representations along with certified copy

of this order within a period of fifteen days from today. If such representation is preferred by the petitioner within the aforesaid stipulated time, the authority concerned shall dispose of the aforesaid representation of the petitioner by speaking and reasoned order, strictly in accordance with law, with expedition, say within a period of two months from the date of receipt of the representation and thereafter communicate the decision thereof to the petitioner forthwith.

7. With the aforesaid direction, the writ petition is **disposed of** finally.
