ORAL ORDER

2 29-02-2024 The present writ petition has been filed seeking the following relief:-

"(i) For issuance of appropriate writ/ order/ direction in the nature of certiorari commanding the respondents to grant pay the scale and grade pay in the scale of Rs. 4000- 6000 instead of pay scale/grade pay the scale of 3050 to 4590 from date of appointment as clerks also appointed on compassionate ground have been granted the higher scale with arrears of dues of salary in the revised with all consequential benefits. In the light of this Hon'ble Court's order dated



25.9.2023 passed in C.W.J.C. No. 11955 of 2023.

(ii) For issuance of appropriate writ/order/ direction nature of certiorari commanding the respondents to consider the case of petitioner in accordance with the order vide letter no. 759 dated 02.05.2023 issued by the District Magistrate, Nalanda and similar order passed by the C.S.-cum-C.M.O. West Champaran, Bettiah, vide letter no. 1165 dated 20.05.2023 the C.S.-cum- C.M.O., Saharsa vide letter no. 1247 dated 03.07.2023 the C.S.-cum- C.M.O. Rohtas vide letter no.2100 dated 21.07.2023 etc. and aforesaid authority consider the similar other employees cases in the light of L.P.A. No. 1 of 2016.

(iii) For issuance of appropriate writ/order /Direction to the respondents to make payment of the petitioner in the light of L.P.A. No. 167 of 2016."

2. At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the District Magistrate, Nalanda for redressal of his aforesaid grievances. Liberty, so sought, is granted.

3. It is needless to state that in case



appropriate representation is filed, within a period of two weeks from today, the District Magistrate, Nalanda shall dispose off the same by passing a reasoned and a speaking order, in accordance with law, within a period of six weeks, thereafter.

4. The writ petition stands disposed off on the aforesaid terms.
