- 1. This is an application for condonation of 93 days delay in preferring the connected civil revision application.
- 2. Mr. S. Syngkon, learned counsel appearing on behalf of the respondent submits that an objection application has been filed, indicating that though there are 7(seven) petitioners, there is no authorization, authorizing the petitioner to present the civil revision or the instant condonation application, on their behalf also.
