## <u>ORDER</u>

30.09.2024

By this petition, the petitioner herein is seeking a direction upon the respondents to release the admitted liability of the contract works executed by the petitioner. It is prayed that the respondents be directed to release the outstanding payment of Rs.8,64,000.00 along with interest @ 18% per annum from the date of completion of the work.

- 2. The respondents are stated to have engaged the petitioner for execution of following works:
  - i) Restoration of MTC by way of pitching/Grouting/Lining and removal of Mulba silt at RD 14430 mtr.; and
  - ii) Restoration of pitching/grouting at RD14400m and including clearance of mulba from RD 14100 mtr. Of MTD; and
  - iii) Restoration of MTC by way of pitching/grouting/lining and removal of mulba silt at RD 14430 mtr of MTC.

The petitioner is stated to have completed the allotted all the three works. The petitioner claims to have approached the respondents for release of the amount due to him but he has got nothing except assurance from the respondents that the amount will be released after arrangement of funds.

3. Petitioner herein is aggrieved of the inaction of the respondents for

causing delay in releasing the payment due to him for execution of the works

by him and, as such, is seeking a direction upon respondents to release the

outstanding amount of Rs. 8,64,000/-.

4. It is stated that after completion of the works, petitioner submitted bills

to the concerned authorities. Petitioner has placed on record copies of the

bills/vouchers submitted to the respondents, perusal whereof reveals that

vouchers have been endorsed by the respondents.

5. Learned counsel for the petitioner submits that he would feel satisfied if

the respondents are directed to consider the case of the petitioner for release of

the outstanding amount of Rs. 8,64,000/- in his favour.

6. Mr. Amit Gupta, AAG, learned counsel appearing for the respondents,

states that he would not be averse to the proposition made by the learned

counsel for the petitioner.

7. Having regard to the prayer made by learned counsel for the petitioner,

the instant writ petition is disposed of at its threshold, with a direction to the

respondents to consider the claim of the petitioner as projected in the writ

petition and take a decision thereon within a period of two months from the

date a certified copy of this Order is made available to the respondents subject

to verification of the requisite bills under rules. The decision so taken by the

respondents shall be conveyed to the petitioner.
