Order on Board

Per Ramesh Sinha, (Chief Justice) 25.10.2024

- Since similar issues are involved in this bunch of writ petitions, therefore they are being heard together and disposed of by this common order.
- 2. At the very outset, learned Advocate General submits that he has filed some documents to show that the show cause notices which were issued to the petitioners on 14.08.2024 and on other dates were not in fact served to the petitioners. Though it is stated that it was served to some authorized person of the petitioner's company but he has fairly submitted that there is no documentary proof to show that the person upon whom the show cause notices were served, were actually related to the petitioner's company.
- 3. In view of the above submission, this Court deem it appropriate to dispose all the petitions with a direction to the respondents'

authority to consider the reply of the petitioners in view of the show cause notice issued to them and after giving them due opportunity of hearing pass a speaking order within a period of 8 weeks from today.

- It is directed that the NIT in question shall be kept in abeyance till
 the disposal of the reply filed by the petitioners to the show cause
 notices.
- 5. With the above observations, the writ petitions are accordingly disposed of.
