Legislative Assembly (Disqualification on Ground of Defection) Rules, 1986 and without following the principles of natural justice and issuing Letter No.5/Legn./ 2024-5 dated 25.01.2024 fixing the date of hearing of D.P.No.4 of 2024 as 29.01.2024 by forfeiting the right of the petitioner to file counter without even issuing necessary documents as illegal, arbitrary, violative of principles of natural justice and unconstitutional and consequently set-aside the same and direct the 2nd respondent to conduct hearing of D.P.No.4 of 2024
