The Court made the following Oral Order:

Heard Sri M.R.Tagore, Learned Counsel for the Writ Petitioner, Sri Y.B.Ramesh, Learned Assistant Government Pleader for Services-IV appearing for the Respondent Nos.1 & 3 to 6 and Sri S.Raju, Learned Assistant Government Pleader for Services-I appearing for the Respondent No.2.

- 2. Sri Y.B.Ramesh, Learned Assistant Government Pleader for Services-IV has submitted a copy of the Order passed by the Division Bench of this Court to submit that the Writ Petitioner herein is appointed on temporary basis on a consolidated pay as Superior Field Worker and that the case of the Writ Petitioner is squarely covered by a judgment rendered by the Division Bench of this Court dated 10.01.2024 in W.P.No.21294 of 2023. The Division Bench of this Court has held that the persons who are not appointed on regular basis are not entitled to the benchit of extension of age of superannuation vide G.O.Ms.No.15 dated 31.01.2022.
- 3. Having considered the submissions of the Learned Assistant Covernment Pleader, this Court is of the opinion that the Order passed by the Division Bench of this Court dated 10.01.2024 in W.P.No.21294 of 2023 is binding on this Court.
- 4. The same Division Bench, in W.A.No.770 of 2022 by Order dated 13.02.2024 had held that the Official Respondents are free to re-engage services of the Writ Petitioner or any other similarly situated person, if they so desire.
- 5. Having regard to the Judgments rendered by the Division Bench of this Court dated 10.01.2024 in W.P.No.21294 of 2023 and dated 13.02.2024 in W.A.No.770 of 2022, this Court is of the

EXFREDE ON THE

view that this Writ Petition cannot be entertained since the ratio of the Order in W.P.No.21294 of 2023 dated 10.01.2024 would squarely bind this Court. However, the observations made by the Division Bench of this Court in W.A.No.770 of 2022 on 13.02.2024 would also bind this Court. Accordingly, this Court observes that the Respondents are free to re-engage the services of the Writ Petitioner, if they so desire.

- With the above observations, this Writ Petition is disposed of. No Order as to costs.
- Interlocutory Applications, if any, stand closed in terms of this Order.
