Heard Sri Thandava Yogesh, Learned Counsel for the Writ Petitioner, Smt. T.Radha Rani, Learned Assistant Government Pleader for Revenue.

- 2. It is the submission of the Learned Counsel for the Writ Petitioner that the proceedings with regard to mutation of the name of the Petitioner with regard to an extent of Ac.4.75 cents in Sy.No.89 (situated in Nagisetty Palli, B.Matam Mandal, Y.S.R. Kadapa District) is pending on the file of the Revenue Divisional Officer (Respondent No.3) *vide* Case No.E/48/2023.
- 3. Having regard to the facts and circumstances, this Court deems it appropriate to dispose of this Writ Petition with a direction to Respondent No.3 to consider the case of the Writ Petitioner on merit and in accordance with law and pass a Speaking Order within six weeks from today and communicate such Order to the Writ Petitioner forthwith.
- 4. During the enquiry, the Respondent No.3 is directed to issue advance Notices to such parties, who are likely to be effected and also taking into consideration the documents and submissions of such parties before passing a final Order.
- 4. Writ Petitioner is directed to submit a copy of this Order to Respondent No.3 within one week from today.
- 5. With these observations and directions, this Writ Petition stands disposed of. No Order as to costs.
