The Court made the following:

ORDER:

This Criminal Petition under Sections 437 and 439 of the Code of Criminal Procedure (for short 'the Code') has been filed by the petitioner/A.1 seeking regular bail in Crime No.18 of 2024 of Munchingiput Police Station, Alluri Sitharama Raju District, registered for the offence punishable under Section 34(a) of the Andhra Pradesh Excise Act (for short 'the Act').

2. Heard Sri J.Krishna Praneeth, learned counsel for the petitioner, and Sri V.Farooq Khan, learned Assistant Public Prosecutor representing the respondent/State.

- 3. Learned counsel for petitioner would submit that in absence of the petitioner, a raid has been conducted and the liquor worth Rs.10,84,800/- has been seized by the Excise officials. Learned counsel further submits that while conducting search and seizure, the police did not follow the procedure as contemplated under Section 55 of the Act and that the petitioner has been in judicial custody for the last 45 days. Hence, prays for release of the petitioner on regular bail.
- 4. Learned Assistant Public Prosecutor would submit that so far six witnesses have been examined, investigation is not completed and prays for dismissal of the petition.
- 5. Considering the submissions and a fair look at the material placed on record, crucial part of the investigation is over since six witnesses were examined, who are police officials. In view of the fact that the petitioner has been in judicial custody for the last 45 days, it is desirable to release the petitioner on bail.

6 In the result, the Criminal Petition is allowed with the following conditions:

- i. The petitioner/A.1 shall be released on bail on his executing a personal bond for Rs.20,000/- (Rupees twenty thousand only) with two sureties for a like sum each to the satisfaction of the learned Judicial Magistrate of First Class, Paderu.
- ii. On release, the petitioner shall appear before the Station House Officer, concerned, once in a week i.e., on every Sunday between 10.00 a.m. to 05.00 p.m. till filing of the charge sheet.
- iii. The petitioner is directed not to hamper the investigation and tamper with the prosecution witnesses.

iv. It is made clear that the petitioner shall scrupulously comply with the above conditions and breach of any of the above conditions will be viewed seriously and prosecution is at liberty to move an application for cancellation of the bail.

As a sequel thereto, miscellaneous petitions pending, if any, shall stand closed.
