- Heard Sri V.S.R.Anjaneyulu, learned Senior Counsel representing Ms.T.Pooja Deepti, learned counsel for the petitioner and Smt.Uma Devi, learned Standing Counsel for the respondents.
- 3. Learned Senior Counsel appearing for the petitioner submits that on the application filed by the petitioner, the respondent authorities already granted an interim order extending the license of the petitioner pertaining to the Stall in Platform No.1 till 30.11.2024.

- 5. Having regard to the above submissions and in view of the facts and circumstances of the case, this Court is of the considered opinion that the interim order granted by the respondent-authorities shall be

extended to the Stall No.14 situated in platform Nos.4 and 5 at Vijayawada Railway Station as well till 30.11.2024.

6. With the above observation, this writ petition is closed. No costs.

As a sequel, miscellaneous applications pending, if any, in this Writ Petition shall stand closed.
