### ORDER:

Heard the learned counsel for the petitioner and learned counsel for the respondents.

The writ petition is filed for following relief:-

To issue any nature of writ of mandamus declaring the action of the respondent No.3 directed the 4th respondent to stop the issuance of the ST community Certificates to the Thanda Kamsali/Sugali Kamsali/Sanar people of Singam palli thanda, Atmakur mandal, Anantapur District Rc.No.MC.35569/2007 proceeding through dated 02-10-2007 is as illegal, arbitrary, unjust and consequently direct the respondents to set aside the said proceedings and pass such order or orders.

The learned counsel for the petitioner submits that the proceedings in RC.No.MC.35569/2007 dated 02-10-2007, issued by the 3rd respondent, prohibiting the issuance of Scheduled Tribe (ST) community certificates to the Thanda Kamsali/Sugali Kamsali/Sanar people of Singam Palli Thanda, Atmakur Mandal, Anantapur District. Consequently, the 4th respondent has not issued ST community certificates to the petitioner, despite the fact that Sugali Kamsali community is recognized as a Scheduled Tribe under the synonyms and subgroups of Banjaras. However, on 24.08.2007, the 1st respondent directed the 3<sup>rd</sup> respondent to conduct an enquiry and take necessary action regarding the alleged issuance of false certificates to the Kamsali Sugali community. The 3rd respondent, without conducting enquiry, issued proceedings RC.No.MC.35569/2007 dated 02-10-2007 directing the 4th respondent to stop the issuance of ST certificates to the Thanda/Sugali Kamsali community in Singam Palli Thanda until further orders. Hence, this writ petition.

The learned Government Pleader for the respondents submits that the members of the Sugali community are not Scheduled Tribes and their community is not mentioned in the list of Scheduled Caste and Scheduled Tribes under the Andhra Pradesh (Scheduled Castes, Scheduled Tribes

and Backward Classes) Regulation of Issue Community Certificates Act, 1993 (Act 16 of 1993).

This Court after hearing both the learned counsel noticed that it is a fact that "Sugali Kamsali" is not mentioned in Act-16 of 1993, and observed that there is a report in their favour dated 07.06.2001 by which the Director of Tribal Cultural Research and Training Institute, Government of Andhra Pradesh, conducted an enquiry and clearly recommended that Sugali Kamsali community people are to be treated as Scheduled Tribes. No reasons were mentioend as to why the report is not being followed.

In addition to this, there are number of orders passed by the learned single Judges of this Court including a common order in WP.Nos.21084 of 2010 and 20713 of 2011, wherein the benefit of an interim order was extended not only to the petitioners therein, but also to all other members of the said Village, who are on the same footing. Till date, the further enquiry has not been completed. From 2007 to 2019, the situation is still in a limbo.

In that view of the matter, this Court is of the opinion that the enquiry cannot be kept pending for years. There should be a quietus to this issue.

The respondents are therefore, directed to initiate de novo proceedings or as an alternative measure accept the report submitted earlier by the

Director of Tribal Cultural Research and Training Institute bearing R.C.No.263/2001/TRI/TEEC., dated 07.06.2001. The option is left open to the Government either to conduct a fresh de novo or to consider the earlier report.

In this interim period, the respondents are directed not to reject any application made by the people of Singam Palli Thanda, if it is otherwise in order and contains all the necessary details. It is needless to say that any certificate that is issued will be subject to result of the enquiry that will be conducted by the Government or its acceptance of the earlier report.

With the above directions, the writ petition is disposed of. No order as to costs.

As a sequel, miscellaneous petitions, if any, pending shall stand closed.
