ORAL ORDER

1. Petitioner is before this Court seeking for the following reliefs:
 - i) *Issue a writ or order in the nature of Mandamus or any other appropriate writ or order or direction, directing the learned IV Addl. Civil Judge (Sr. Div) at Mysuru to dispose the FDP No.98/2023 at Annexure C without causing unnecessary delay. In the interest of justice.*
 - ii) *Grant such other order or direction as this Hon'ble Court deems fit in the facts and circumstances of the case in the interest of justice and equity.*
2. By way of above petition the petitioner seeks for a direction to the FDP Court for expediting disposal of the FDP No.98/2023. Being of the considered opinion that the said FDP is filed in the year 2023, such a direction cannot be issued.
3. The writ petition is hereby ***dismissed.***
