This criminal miscellaneous case is filed to quash the proceedings in S.T. No.3152/2016 on the file of the Judicial First Class Magistrate Court-I, Neyyattinkara.

2. It is a private complaint filed by the 2<sup>nd</sup> respondent alleging offences punishable under Sections 341, 294(b), 323 and 506(i) IPC. The petitioner was a Police Officer.
