JUDGMENT

The petitioner was in the service of the KSRTC as a conductor from 1988 till he resigned from its service on 06.01.1995. The grievance of the petitioner is that even after repeated requests, benefits of Provident Fund, Staff Welfare Fund and gratuity are not so far disbursed to him. The petitioner states that he has recently undergone liver transplantation and he is in need of money for his treatment. The petitioner has submitted Exhibit P13 representation dated 24.06.2024 in this regard, before the 2nd respondent. However, the 2nd respondent has not so far responded to the same. Accordingly, the petitioner has filed this Writ Petition for a direction to the 2nd respondent to consider and pass orders on Exhibit P13 expeditiously.

2. Heard the learned counsel for the petitioner and Sri. N. Mahesh, the learned Standing Counsel for the respondents.

3. In the facts and circumstances of the case and having regard to the submissions made across the Bar, there will be a direction to the 2nd respondent to consider Exhibit

P13 representation as expeditiously as possible, at any rate, within a period of six weeks from the date of receipt of a certified copy of this judgment.

The writ petition is disposed of.
