# **JUDGMENT**

Dated this the 20th day of December, 2024

The appointment of the petitioner under the 4<sup>th</sup> respondent Management as permanent UPSA was approved on Daily Wages from 23.06.2008 to 31.03.2009 and on salary scale of permanent Teacher from 01.06.2010 onwards, by the 3<sup>rd</sup> respondent, holding that the first spell of appointment is not for the entire academic period.

- 2. The Appeal preferred by the management was dismissed without considering the facts. Therefore, the petitioner submitted Ext.P7 Appeal before the 1<sup>st</sup> respondent. Ext.P8 reply under Right to Information Act evidences that Ext.P7 Appeal is still pending. The petitioner is entitled for regularization of her appointment from 23.06.2008. Hence, the petitioner has filed this writ petition.
- 3. Government Pleader pointed out that Ext.P7 submitted by the petitioner is dated 12.09.2012.

4. Counsel for the petitioner would point out that as per the information received, as per Ext.P8, the said representation has not been considered so far.

5. Taking into consideration the facts of the case, I am of the view that if no decision is taken on Ext.P7 so far, then the 1<sup>st</sup> respondent can consider the same and decide the matter in accordance with law.

The writ petition is accordingly disposed of directing the 1<sup>st</sup> respondent to consider Ext.P7, if the said representation is still pending, and take appropriate decision thereon within a period of four months. If order is already passed on Ext.P7, the petitioner shall be provided with a copy of the order.
